

## American Rottweiler Club Sweepstakes & Futurity Judges List (Revised 07/30//09)

Listed below are approved Futurity and Sweepstakes judges who have submitted an ARC application substantiating their credentials to meet the ARC Board Guidelines for Regional and/or National Specialties. Once a Judge has judged an ARC National Futurity or Sweepstakes, 3 National Specialties must pass before that individual is again eligible to judge either the Futurity or Sweepstakes at the National. A National Specialty judge may not accept a Rottweiler judging assignment in the 3 months preceding the National. An individual may judge a Sweepstakes, whether Puppy or Veterans, only once every 3 years in each Region.
