If limits are not reached by closing (March 30th, 2022) we will accept Late entries until April 4, 2022 No Day of Show Entries will be accepted.

Any entries received before opening date -will be destroyed. Entries allowed by mail only. Crazy 8's will be limited to 25 runs.


Entry fees are \$15 for Instinct, \$20 for Novice and Open and \$25 for Senior, Master and Crazy 8's.

Late Entries are \$20 for Instinct, \$25 for Novice and Open and \$30 for Senior, Master and Crazy 8's.

Late entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations may not be sent for Late entries.

Move ups will be **not** allowed on the same day but will be accepted from Saturday to Sunday





EXHIBITOR INFORMATION

Because this is occuring with a National Specialty we are aware that other events will be running at the same time. We cannot hold up a ring if a competitor is competing in another event on the trial grounds. Competitors that enter more than one event will be doing so at the risk of missing their barn hunt runs.

For timing and judge loading the trial may be run in a non traditional order. The order will be sent out with the final confirmations. Move-up forms will be available at the Secretary's table. Move ups only between Saturday and Sunday's trials. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or by e-mail.

Make check payable to MCAC. Send entries and fees to the trial Secretary. The entry forms are attached - it is prefered that individuals use the online entry form located on the Barn Hunt website. Refunds will be made in full if a dog is pulled before 3/29/22 pre-entry closing date but not after -except for a veterinary excuse.

Dogs must have a Barn Hunt registration number. You can auto generate entry forms from the Barn Hunt website. These need to be printed out, signed and mailed to the trial Secretary. Registration number, online entry forms and rules can be found at www.barnhunt.com.

Any Judge of Record at this Event may be used as a Load Balancing Judge in any ring. Judge of Record and Event Official dogs may be judged prior to Event start or as the first dogs of the Event

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

AWARDS: Ribbons will be awarded for all qualifiers in the Instinct test and all regular classes including Crazy 8's. Ribbons will be awarded for first through fourth place for qualifiers in Novice through Master. High in Class ribbons and new title ribbons will also be awarded.

These trials will be held outdoors on padded cement, under a pavilion. Blinds are 20x20 and located in the parking lot next to the pavilion. Hanidcapped parking is available - please let trial secretary know if you need a space. There is crating space located nearby that is also a covered pavilion. Crating space is first come, first served and will be limited (under the pavilion). Crating in your vehicle is a possibility and might be encouraged depending on time of arrival. There is plenty of green space to crate at the site as well. Please make sure your crate is secure as dogs may be highly excited and the nearby grounds are not fenced in.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial in panties. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Dog Aggression: Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.
