

(limits of 8 Cattle, 8 Ducks, 34 Sheep combined trial & tests) Tests could be sheep and/or goats.

Alternates being placed on waitlist will be notified when entry is received.

Drawing for Run Order will be held on March 20, 2024 at 8:00pm by Trial Secretary at address listed.

A SEPARATE ENTRY FEE IS REQUIRED FOR ENTRY IN EACH CLASS and EVENT

Included in Entry Fee is an AKC Recording Fee of \$3.50 for each entry in Herding Trials and Tests.

There is an additional fee of \$2.00 per entry for online entries.

Entry forms can be mailed and then followed up with PayPal payment to chdogevents@aol.com. Entries are considered accepted when entry form and payment are matched up – confirmation will be sent out as soon as that occurs.

A trial program/schedule will be mailed to each entrant as soon as practical after closing of entries.

Entry fee will not be refunded in the event that a dog is absent, (unless replaced by an alternate), disqualified, excused by Veterinarian or Judge or barred from competition by action of the Trial Committee.

Post Dated Checks & Returned Checks do not constitute a valid entry fee. The Trial Secretary will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

Bitches in season will run in catalog order for the trial and at end of tests.

Please notify the Trial Secretary at the beginning of the trial if you have a bitch in season.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

No entry fees will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes and/or any other cause beyond the control of the Club or the Trial Secretary.

Entries will not be accepted without fees or signatures. There will be **no refunds** for duplicate entries. Changes, additions or corrections to entry forms must be received in writing, fax or by email prior to close of entries. Those received by telephone are not acceptable.

No dog wrongly entered in a class may be transferred to another class nor can a dog be withdrawn after entries have closed for a refund unless there is a waitlist/alternate that can fill that entry. The owner or agent assumes all responsibilities for wrong or incomplete information of the entry blank.

Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

Entries must be made on an included AKC entry form or photocopy of the Official AKC entry form with the Agreement and Rules or they cannot be accepted.

Confirmation of Entry will be sent to the email address(s) on the Official AKC entry form within 48 hours of receipt, if you do not receive email confirmation promptly, please contact Trial secretary. Judging Schedule will be sent after close of entries.

EXHIBITOR INFORMATION:

All dogs must be held on leash or otherwise restricted except when working stock. Under NO circumstances will dogs be allowed to disturb the resting stock or interfere from outside the arena with another dog's performance in the arena. Any dogs aggressive to person or stock will be removed. (See Chapter 1, Section 20 of the American Kennel Club Herding Regulations)

All AKC rules regarding conduct will be strictly enforced.

Dogs must be ready for judging. Neither the Club nor its Trial Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents on progression of Judging. **Owners or agents alone are responsible for the presence of their dogs at the trial site and appropriate arena.**

The trial hosting Club, the Trial Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property while at or on the trial grounds, or in transit to or from the trial. And assumes no responsibility for injury to children.

The hosting club will exercise every precaution for the safety of dogs exhibited, but it must be understood that neither the club, site or Trial secretary will be responsible for any injury, damage, or loss. It is understood that all dogs at this trial are in the care and custody of the owners or owner's agents during the entire trial weekend.

There shall be no drilling or intensive /abusive training of dogs on the Trial grounds.

Exhibitors are required to clean up after the dogs that they are trialing or which are under their care or control. This requirement includes both while in the arena or at any location on our trial site. Clean up tools and supplies will be available, see Trial Secretary if needed.

Exhibitors should follow their veterinarian recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Parents are solely responsible for their children and are expected to keep them supervised and controlled at all times for their own safety.

All regulations governing the use of this facility, and all regulations and decisions of the Trial Committees of these trial giving clubs on this day will be strictly enforced, including and not recorded in this Premium List.

All persons entering this dog trial/event, hereby waive any claim for damages against The American Rottweiler Club, its members or the Trial secretary in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation. The club(s) is solely responsible for determining if the said animal is in distress.



