**Late Entries and Day of Show Entries** will be accepted, space permitting. Late Entries and/or Day of Show Entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations may not be sent for Late Entries.

**Trial Grounds:**

Indoors on concrete, matted ring, heated

**Blind Information:**

Blind will be 10' x 20' and located 20' from the ring

Instinct/Novice/Open - blinds up to 6 dogs

Senior/Crazy 8's - blinds up to 5 dogs

Master - blinds up to 4 dogs

**Move-Up/Down/or Over:**

Move ups allowed for Saturday to Sunday only. Sorry, no same day move ups allowed due to the reverse running order.

**Crating:**

A crating area will be available inside the building

**Height Divisions:**

Small: 15" and under

Medium: 15.1" to 22"

Large: Over 22"

**Special Awards:**

There will be a special award for the highest placed Rottweiler in each class.

**Awards:**

Qualifying ribbons for all qualifying scores.

Placement ribbons by height for first through fourth place for all A classes and Master B.

Placement ribbons for first through fourth place regardless of height for B classes in Novice, Open, and Senior.

High in Class rosettes for all A classes and Master B.

New Title rosettes for a new title in any class.

Custom rosettes will be ordered for all RATCH and above titles.

**Bitches in Season:**

Bitches in season may compete in a Barn Hunt event. They will be run at the end of each class. Bitches in season must wear pants at all times except when being pottied. If bringing a bitch in season, please inform the trial secretary prior to the start of the trial and inform all exhibitors at the judge's briefing.

**Refund and Cancellation Policy:**

After the closing date, entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the trial committee.

Every attempt will be made to hold this event as scheduled. No event fees will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of the public enemy, or any other causes beyond the control of the event committee.

## **Miscellaneous:**

Any program changes and final instructions will be emailed after closing.

Dogs may enter both Instinct and Novice class in the same trial until the dog has earned the Novice title.

All dogs must be on leash and under control while on trial grounds except while showing. Flexi leashes, electronic collars, bark collars, head halters, uncovered prongs, and muzzles **are not allowed to be used on trial grounds.**

Disruptive dogs will have to be crated outside of the trial area.

There is no smoking on trial grounds.

Please pick up after your dog and dispose of waste in appropriate containers outside the building.

Dogs must have a Barn Hunt Number to participate in this event.
